FIRE CHIEF:

ASSESSOR:

July Board of Review is July 18 @ 10 am, there is one item to review.

Indian Summer is aware of the error, roughly \$10,548.00. We are in the process of correcting the error, with the proper agencies.

COMMISSIONER:

County has received 6 proposals for the extensive search for the replacement of Fabion.

County is in discussions for an SRO at the ESD. They have received a grant to help with the cost. Currently the sheriff's office is short on people.

County is reviewing the Housing Repair Project. \$55,000 has been used to day, looking to add another \$17,000. County will get dollars back if home is sold or if home is refinanced. A question was asked if a lien is placed on the home, Commission Hull was unsure, but would check.

County reviewing an agreement between the County Treasurer and the land bank to help with property clean up.

Sheriff Cole is looking to purchase a night vision drone. Cost is roughly \$8,000, they have \$3,500 in donations to date.

County broadband is still on the docket. Decisions to be made as to where to take the funds to see what the cost would be to provide countywide broadband. The charge to do the research 8s \$68,000.

County also looking at the setbacks associated with Solar Energy.

Clerk Gerbers made a motion to have the floor redone with the ceramic seal, supported by Supervisor Dittmer to have this completed in November, all in favor, motion carried.

Discussion was held on the parking lot construction, will be in four phases. A motion was made by Supervisor Dittmer, supported by Trustee Thurow to move forward with phase 1, all in favor, motion carried.

Discussion was held on the creation of the township website. A motion was made by Supervisor Dittmer, supported by Clerk Gerbers, Treasurer Griffis was not in favor, with 3 yea's and 1 nay, motion carried.

NEW BUSINESS:

Household Hazardous Waste will be August 19 at the road commission. Possible car tire collection in September.
